- 1. Call to Order and Roll Call. Chair Anderson called the meeting to order at 10:02 a.m. A quorum was established.

- 4. 2025 Application Cycle, Recommendation of Projects for Legislative Authorization. Ms. Angela Quintana presented 84 applications for projects to be recommended to the Legislature for authorization for potential funding from the Water Project Fund, totaling more than \$256 million. Projects recommended to the Legislature will be invited to complete a Readiness Application that initiates a review of regulatory compliance, including mandatory spending of prior WTB awards. Applicants who have open WTB awards from 2023 or prior must submit requisitions by January 23, 2025, to be counted towards the Final Expenditure Target. All applicants will be notified, as part of the readiness application process, if they have not passed their compliance requirements and will be given until March 14, 2025, to either show evidence of compliance or submit a waiver that provides justification for the compliance request.

The WTB Project Management Team will review the waiver requests and make recommendations to the WTB and Project Review Committee. Staff expects to present the waiver requests to the Board in early April 2025 and recommend final funding to the Board at the April 22, 2025, meeting. The Project Review Committee has reviewed and concurs with staff's recommendations.
